Fees

Tournament fees are as follows:

School Fee: \$30.

Fee per debater in-person: \$25 (includes lunch and pizza for awards).

Fee for in-person participant (coaches/judges/observers): \$15

Uncovered Team Fee: \$90 for the first team; \$180 for additional uncovered teams.

We do not waive judging fees for any reason.

Amount due is set on Tuesday Night even if you drop after that as we have to pay for food we order and we have to pay for any judges we have hired (food service and judges need to know by Tuesday night if they are needed or not).
